JIRECT DEBIT MEMBERSHIP TERMS & CONDITIONS

'RINCIPAL TERMS

This agreement commences once you have indicated your acceptance in the Declaration section of the web sign up process. In some locations you can choose to delay the start date of your membership by up to 1 month. If you vant to bring this date forward, please contact us at memberships@q-gym.com and we will be more than happy to liscuss your options. Please do note, however, that the terms in the Money Back Guarantee section of these terms nay then apply in that situation. 3This agreement will become binding on you and us when we contact you to confirm your membership application has been accepted, at which point a contract will come into existence between you and us. 4You will be entitled to all the rights and privileges exercisable for the Type of Membership shosen. 5You cannot transfer this agreement to anyone else.

EES AND CHARGES

The Joining Fee (if one is payable) will be collected straight away upon signing up, all memberships on the direct lebit will then not be charged until the opening off the gym, unless joining after the gym opening in which the direct lebit will start straight away with any outstanding payment on the current month. . These fees are not refundable inder any circumstances with the exception of the Money Back Guarantee detailed below. Joining fees are applied o cover the initial administration costs associated with setting up a new membership and direct debit igreement.2If you are looking to upgrade your membership there maybe an admin fee charged at the point at vhich you upgrade.3A fee to purchase a gym key is applicable unless your memberships include the key purchase. If any Direct Debit is returned unpaid or any cheque is returned unpaid or if any other form of payment is not ionoured for whatever reason, you shall pay us on demand an administration fee of £20. If, despite us having notified you of a missed payment, further payments are missed, we reserve the right to, at our sole election, either uspend or terminate your membership, upon having given you written notice of our intention to do so. We may resent an option to reduce the administration fee if the outstanding amount is paid online within 7 days of becoming due.5You agree to advise us immediately of any change to the Members Details provided.6No additional nonthly charge is applied if you freeze your membership. Your membership can be on freeze for a maximum of 3 nonths after which your membership will automatically be un-frozen and will revert back to your monthly rate. reeze only applies to monthly memberships on medical grounds with proof of reason.

RICES

From time to time we may need to increase the price of membership. We will give you at least 1 full months' notice of any incoming price increase and will make it very clear when the price increase will take effect and how much our membership will cost after the increase. During this period, you will have your usual right to terminate your nembership in accordance with the membership terms and conditions and rules. If you do not terminate the nembership by the date given to you in the notice, then the price of your membership will be increased in accordance with our notice.

ERMINATION

Please call Member Services for options ivailable to you or for any further information.2In the above circumstances your membership will remain in force ıntil the day before your next payment is due, at which point it will automatically terminate. 3As per the Consumer Contracts (Information, Cancellation and Additional Charges) Regulations 2013 you are entitled to cancel your nembership and receive a full refund of any fees paid within 14 days of completing your membership application orm. However, as per regulation 36 of Consumer Contracts (Information, Cancellation and Additional Charges) Regulations 2013, if you select to commence your membership immediately, or you ask us to start your nembership early, you agree that if you subsequently cancel your membership within the 14 day period, you will be efunded any monies paid, less an amount for the membership you have already used. As an example of how this vorks, if your membership fee is £15 per month and you cancel your membership after 10 days of it commencing having asked us to start it immediately) we shall refund you £10, keeping £5, which represents the membership you nad used up to the point of cancellation.
